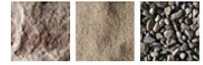

## PMD members approve special assessment for ACGIH NIC response

In a conference call May 9, PMD approved a special assessment of \$650 per member company to help the association respond to a new threat to the industry. The problem at hand is an American Conference of Governmental Industrial Hygienists (ACGIH) proposal to

significantly lower ACGIH's recommended exposure limits for calcium carbonate. The proposed change, which is based on a highly questionable German study, is of major concern because ACGIH exposure limits are frequently incorporated by reference by OSHA, MSHA, and other agencies.

NSSGA has made the issue a top priority. PMD-NSSGA staff has been working closely in recent weeks with a coalition of groups, including the Industrial Minerals Association-North America (IMA-NA), the National Lime Association (NLA), the Portland Cement Association (PCA) and others, to coordinate a response.

Our coalition is retaining the services of a respected inhalation toxicologist to draft comments to ACGIH. The \$650 per company assessment will cover PMD's share of the \$18,000 cost of preparing those comments. Our

position: It's critical that we build a strong case against the proposal now in anticipation of the possibility of later having to take the issue to Congress, the courts, or the court of public opinion.
